1	SEC. 2. DESIGNATION OF FUNDS TO PAY COSTS OF RENAM-
2	ING DEPARTMENT OF DEFENSE.
3	(a) FINDING.—Congress finds that—
4	(1) title II of the National Security Act of 1947
5	(61 Stat. 499, chapter 343) established the National
6	Military Establishment to replace the Department of
7	War; and
8	(2) the National Military Establishment was
9	subsequently renamed the Department of Defense,
10	by an amendment to the National Security Act of
11	1947 made by section 4 of the National Security Act
12	Amendments of 1949 (63 Stat. 578, chapter 412).
13	(b) Sense of Congress.—It is the sense of Con-
14	gress that, as the Department was established and named
15	by an Act of Congress, the name of the Department can
16	be changed only by an Act of Congress.
17	(e) Designation of Funds.—
18	(1) In general.—The Secretary shall pay cov-
19	ered costs by reallocating amounts available to the
20	Secretary for travel expenses to pay such costs.
21	(2) Additional funds.—If the total amount
22	of covered costs exceeds the total amount available
23	to the Secretary for travel, the Secretary shall pay
24	the remaining amount of covered costs by reallo-
25	cating amounts available to the secretaries of the

military departments for travel to pay such costs.

1	(d) Report Required.—Not later than one year
2	after the date of the enactment of this Act, the Secretary
3	shall submit to Congress a report on the total amount obli-
4	gated or expended to pay covered costs.
5	(e) Definitions.—In this section:
6	(1) COVERED COSTS.—The term "covered
7	costs" means costs accrued by the Department and
8	associated with the changing of "Department of De-
9	fense" to "Department of War" on physical signage,
10	websites, stationary, printed media, and digital
11	media owned or operated by the United States Gov-
12	ernment.
13	(2) Department.—The term "Department"
14	means the executive department established by sec-
15	tion 111 of title 10, United States Code.
16	(3) Secretary.—The term "Secretary" means
