LEGISLATIVE HIGHLIGHTS IN KEY AREAS

ECONOMIC EMPOWERMENT – FIGHTING FOR MORE OPPORTUNITIES FOR MARYLANDERS TO BUILD WEALTH

- After speaking to small business owners and agricultural leaders across our state, it became clear just how dramatic an impact the President's chaotic tariffs were having. In March, I introduced my first bill, the **Tariff Transparency Act**. This necessary legislation would require the United States International Trade Commission to conduct an investigation on the impact of Trump's tariffs and the threat these tariffs pose to American consumers and small businesses.
- After cosponsoring the original bill, I negotiated the final version of the **Guiding and Establishing National Innovation for U.S. Stablecoins Act (GENIUS Act)**, which creates the first federal regulatory framework for digital assets. The bill will protect consumers interested in engaging with this emerging market and spur innovation to keep America at the forefront of digital assets. The GENIUS Act was signed into law.
- I co-led the **Access to Small Business Investor Capital Act**, which makes it easier for Business Development Companies to invest in small- and medium-sized Maryland businesses, creating stronger local economies and more job opportunities.
- I cosponsored the **Child Care for Working Families Act** to tackle the child care crisis head-on: ensuring families can afford the child care they need, expanding access to more high-quality options, stabilizing the child care sector, and helping ensure child care workers taking care of our nation's kids are paid livable wages.
- I worked with Senator Tim Scott (R-S.C.) to introduce and pass the **Small Business Tax Fairness and Compliance Simplification Act**. This legislation allows beauty industry small businesses, such as hair stylists, barbers, and nail technicians to qualify for the Section 45(B) federal tax credit and provides a safe harbor for these businesses to establish procedures for tipped employees to better report their wages without attracting additional tax liability. The bill was signed into law.

HEALTH CARE – INCREASING ACCESS, AFFORDABILITY, AND RESEARCH EFFORTS

- I introduced my **Bipartisan Uterine Fibroid Intervention and Gynecological Health Treatment (U-FIGHT) Act** alongside Senator Cynthia Lummis (R-Wyo.). Fibroids impact 80% of women, and it is time we take action.
- In June, I introduced the **Medicare and Medicaid Dental, Vision, and Hearing Benefit Act** that would expand Medicare and Medicaid coverage to include dental, vision, and hearing services – combatting a critical gap in coverage and lowering health care costs for families.
- In May, I filed a resolution of disapproval of Secretary Kennedy. The resolution stated that the Senate and the American people have no confidence in Secretary Robert F. Kennedy Jr. I went on to introduce – along with Senator Ron Wyden (D-Ore.) – a [54-page report](#) chronicling every day of RFK Jr.'s costly, chaotic, and corrupt reign as HHS Secretary. Senator Wyden and I continue to build the case for why RFK Jr. must resign or be fired.

EDUCATION AND HOUSING – INVESTING IN EDUCATIONAL OPPORTUNITIES AND LOWERING THE COST OF HOUSING

- I introduced the **Protecting Students with Disabilities Act** to ensure that special education programs within the U.S. Department of Education continue, despite the Trump Administration's drastic cuts to the Department.
- I led the Maryland Democratic Delegation in demanding that the Trump Administration release the \$98 million promised for education funding in the state.
- I introduced the **Jordan McNair Student Athlete Heat Fatality Prevention Act** which would ensure college and high school athletic programs implement heat illness emergency action plans (EAPs) in consultation with local emergency responders, including the operation and use of cold-water immersion equipment. This bill honors Jordan McNair, a freshman on the University of Maryland football team, who tragically passed away from heat stroke in 2018.
- I worked alongside Senator Katie Britt (R-Ala.) in introducing the **Homeless Children and Youth Act (HCYA)**, which would support the youth and young adults experiencing homelessness and ensure that all individuals experiencing homelessness are given the support they need to exit it for good. This legislation expands the definition of homelessness to youth that are eligible for services to help them exit homelessness and would require annual data to be collected and published on homeless children, youth, and families.
- I joined Senator Warnock (D-Ga.) and four Senate colleagues in introducing the **Appraisal Modernization Act**, to address appraisal bias in the home buying and selling processes. This bill would empower Marylanders with more data and tools to fight bias that would lower their homes' values.
- I voted to pass the **Renewing Opportunity in the American Dream (ROAD) to Housing Act of 2025**, which includes four bills I cosponsored: the Bipartisan Community Investment and Prosperity Act, the Bipartisan Whole-Home Repairs Act, the HOME Investment Partnerships Reauthorization and Improvement Act, and the Appraisal Modernization Act.
- Senator Van Hollen and I announced \$200,000 in federal funding for four local NeighborWorks organizations in Maryland to support efforts to lower the cost of housing, expand the local housing supply, support economic opportunities, revitalize neighborhoods, and build stronger and safer communities.
- I have questioned countless Trump nominees on programs important to Maryland, including HOME, CDBG, and CDFIs – all of which are Congressionally-mandated and funded programs spurring housing investment.

CIVIL AND VOTING RIGHTS – DEFENDING OUR DEMOCRACY AND OUR RIGHT TO VOTE

- In September, I introduced the **Deceptive Practices and Voter Intimidation Prevention Act** to address the rise in deceptive voter suppression practices and intimidation in federal elections. This legislation criminalizes knowingly spreading false information about the time, place, manner of voting, or voter qualifications, and threatening or coercing individuals to not vote or vote a certain way.
- I cosponsored the **John R. Lewis Voting Rights Advancement Act of 2025**, which would update and restore critical safeguards to the original Voting Rights Act.

ENVIRONMENT – PROTECTING OUR PLANET AND INVESTING IN THE CHESAPEAKE BAY

- I secured funding for Army Corps infrastructure and environmental projects including **\$61 million for dredging the Baltimore Harbor Channels** and **\$61 million for the Mid-Bay Island Restoration Project**, which will restore habitat with dredged material.
- I was an original cosponsor of the **Chesapeake Bay Conservation Acceleration Act** which aims to reduce agricultural runoff into the Chesapeake Bay.
- I co-led the **Chesapeake Bay National Recreation Area Act** to deliver more federal resources to the watershed region and conserve the Bay's environment.
- I joined Democratic colleagues on the Environment and Public Works (EPW) Committee in pressuring Environmental Protection Agency (EPA) Administrator Zeldin to justify freezes on the Inflation Reduction Act and the Bipartisan Infrastructure Law grant funding.



ACROSS THE STATE

EASTERN SHORE

The Eastern Shore Region consists of **10 counties**: Harford, Cecil, Kent, Queen Anne's, Caroline, Dorchester, Talbot, Worcester, Wicomico and Somerset. Team Alsobrooks attended over **145 events/meetings** from March to November. During her visits, Senator Alsobrooks met with the business community, leaders from the agriculture industry, municipal leadership, and constituents.



Senator Alsobrooks met with rural health care leaders at the Talbot Community Center, for a critical discussion about the persistent health care gaps, including hospital closures and consolidations; chronic provider shortages—particularly in maternal health, behavioral health, and primary care; limited access to transportation, broadband, and telehealth; and higher rates of chronic disease, mental health crises, and substance use.

SPOTLIGHTS

Senator Alsobrooks met with more than 50 agricultural leaders and stakeholders at Layton's Chance in Vienna, Maryland. From tariffs and their impact on fertilizer and crop-protection inputs, to opportunities to expand agricultural exports, to USDA grant management and Avian Flu controls, ensuring efficient grant processes and adequate disease-prevention measures, Senator Alsobrooks had wide ranging discussions with farmers and stakeholders.



WESTERN MARYLAND

The Western Maryland Region consists of **5 counties**: Garrett, Allegany, Washington, Frederick, and Carroll. Team Alsobrooks attended over **160 events/meetings** from March to November, and Senator Alsobrooks has met with representatives, community leaders, and constituents of all five western counties between March and November.



Senator Alsobrooks met with students from Frostburg State University for a town hall. They had a robust discussion about their future, how they will afford to buy their first home, and how they would like to ensure education remains equitable for all students.

SPOTLIGHTS

Senator Alsobrooks heard from an array of constituencies including small businesses, women's health organizations, federal workforce, labor and union workforce, outdoor recreation economy representatives, student organizations and higher education leaders, and the Appalachian Regional Commission. In May, Senator Alsobrooks visited the Allegany County flood zone to hear more about needs after the devastating floods. After the President cancelled flood prevention funding, she fought back during a hearing in the Banking Committee.



BALTIMORE REGION

The Baltimore Region consists of Baltimore City and Baltimore County. Team Alsobrooks attended over **188 events/meetings** from March to November. During her visits, Senator Alsobrooks met with cultural leaders, health officials, seniors, the business community, leaders from the agriculture industry, municipal leadership, and constituents. She also hosted a Utilities Fair, one of three, that helped make residents aware of cost-saving opportunities.



In Baltimore County, the Senator participated in a town hall to join Marylanders in fighting to ensure the Trump Administration does not make cuts to Social Security, Medicare or Medicaid benefits that many Maryland residents rely on for retirement and disability benefits. Senator Chris Van Hollen, Congressmen Kweisi Mfume and Johnny Olszewski, and Councilman Pat Young were in attendance.

SPOTLIGHTS

In Baltimore City, the Senator participated in an event called: “Real People. Real Stories. Resist.” This event was a roundtable gathering where the Senator was able to hear directly from local seniors, veterans, community leaders, healthcare workers, artists, and parents about key issues that are heavily impacting their everyday lives with the Trump Administration. This event was convened at the Reginald F. Lewis Museum in Baltimore City.



PRINCE GEORGE'S COUNTY AND SOUTHERN MARYLAND

Prince George's County and Southern Maryland Region consist of **4 counties**: Prince George's County, Charles County, Calvert County, and St. Mary's County. Team Alsobrooks attended over **79 events/meetings** from March to November. During her visits, Senator Alsobrooks met with the business community, leaders from the agriculture industry, municipal leadership, and constituents. She also hosted a Jobs Fair.



Senator Alsobrooks spent a morning meeting with Calvert County educators to hear both their successes and their concerns, especially around the impact of federal funding losses on schools and students. This was a listening and partnership-focused conversation, with educators sharing on-the-ground realities so she can advocate more effectively at the federal level.

SPOTLIGHTS

Senator Alsobrooks thanked members of the Hillcrest Civic Association for their advocacy on community issues (public safety, neighborhood conditions, and schools), and took questions/feedback about how her work in the U.S. Senate can support their neighborhood priorities.



CENTRAL MARYLAND

The Central Maryland Region consists of **3 counties**: Anne Arundel, Howard, and Montgomery. Team Alsobrooks attended over **109 events/meetings** from March to November.

Senator Alsobrooks met with stakeholders from across Central Maryland during the last year. From meeting with special needs educators and students, to visiting our nation's wounded warriors at Walter Reed National Military Medical Center, to hosting a town hall for federal workers seeking answers in the wake of the Trump Administration's mass firings – the Senator listened to Marylanders to bolster her fight in Washington.



SPOTLIGHTS

Senator Alsobrooks visited The Harbour School in Annapolis, which serves students with developmental disorders and other learning challenges. There, she met with teachers, students, and families and reaffirmed her support for special education.



Senator Alsobrooks also visited the Military Advanced Training Center at Walter Reed National Military Medical Center, a state-of-the-art facility where service members, veterans, and family members use sophisticated prosthetics and cutting-edge equipment to move from injury to independence.

Our Constituent Services team has been working hard to deliver for Marylanders in need. From March to November, our team has received almost 3,000 constituent requests and has processed and closed nearly 90% of those cases thus far. From issues with Medicare and Social Security, to Veterans Affairs and the IRS, we have been honored to get results for Marylanders in need.

HIGHLIGHTS

- ◆ In September, a retired government employee contacted our office about their benefits. They had filed for retirement in January and could not get in touch with anyone to help process their paperwork. Once my office contacted the Office of Personal Management (OPM) they received back pay of over \$7,000 and will now receive their earned \$4,000 per month for the rest of their retirement.
- ◆ Our office learned of a constituent held in ICE custody who was having a medical crisis, suffering from a fever of 104 degrees. The individual was diagnosed with pneumonia and due to our intervention, received the medical care they needed within hours. The constituent is now back in Maryland and released from ICE custody.
- ◆ A constituent had their Social Security benefits approved in 2023. Because of a bureaucratic issue, the payment had been stuck at the payment center since March of 2023. After our office sent an inquiry, the payment was released and the constituent received \$22,000 in back benefits.
- ◆ A constituent requested assistance with a VA benefits eligibility (dependency) claim that had become stuck. The claim was filed back in January of 2024. We followed up with the VA multiple times before they finally told us that the claim had been completed. The claim was indeed approved with backpay. We estimate that the approved claim and backpay was close to \$25,000.
